# Summary of Land Acquisition & Educational Use

Legal description: Lot 322 on SP172124

Street address: 532 Beams Road, Carseldine QLD 4034

Timeline of land acquisition by the State by payment (non-gifting):

- August 1914 widower Mrs Knight sold In-Fee Simple part of the future Lot 322 to the State ("Governor of Queensland") for £1,500
- October 1975 ("Lot 3") part of the future Lot 322 was seized by compulsory acquisition from company Arnott Morrow Pty Ltd with consideration payment. See Queensland Government Gazette No. 50 page 789 stating land "*is taken by the Crown for the purpose of dealing with in any manner in which the Crown land may be dealt*".
- 1973 State dedicated new road (plan used in 1976 subsequent changes)
- 1975 "Lot 3" was subdivided by the State into Lots 1 & 2, with south of Cabbage Tree Creek set aside for future school use (Lot 1) (plan used in 1976 subsequent changes)
- 1976 changes to Lot numbers results in new Lots 1 & 2 combined to create current Lot 322 with south of Cabbage Tree Creek set aside for school use (Lot 2), shown by hand written notation
- 1977 Deed of Grant of Land issued by the State over current Lot 322 for educational purposes to allow for use of the site by North Brisbane College of Advanced Education. Deed was required as an educational use typically requires special zoning provisions
- The use remained in place throughout Queensland University of Technology (QUT) occupation, with the deed rescinded upon QUT vacating the site as no longer operating as an educational facility

as delineated on plan of Survey catalogue No. S1.8285 deposited in the Office of the Surveyor-General and as shown edged red on diagram hereon with all the Rights and Appurtenances whatsoever thereto in anywise. To Have unto the said

COUNCIL OF THE NORTH BRISBANE COLLEGE OF ADVANCED EDUCATION, Its Successors

for ever, Yielding and Paying therefor Yearly unto Us, Our Heirs and Successors, the Quit-Rent of One Penny per acre, if demanded, Upon Trust for Educational Institution (North Brisbane College of Advanced Education) purposes

and for no other purpose whatsoever, But Subject nevertheless to the several Conditions and Reservations contained in and Assented to by the Land Act 1962-1975, the Mines Act 1962-1976 and "The Petroleum Act, 1973 to 1976": AND WE do hereby reserve unto Us, Our Heirs and Successors, all Gold and Minerals (the term "Minerals" to have the same meaning as in the Mining Act 1968-1976), on and below the surface of the said Land, and all Mines of Gold and Minerals, on and below the surface of the said Lands AND WE do hereby also reserve unto Us, Our Heirs and Successors, and to such persons as shall from time to time be duly authorised by Us in that behalf, the free right and privilege of access, including ingress, egress, and regress, into, upon, over, and out of the said Land, for the purpose of searching for or working OIL and MINERALS, or any of them, or Mines of Gold and Minerals, or any part of them, in any part of the said Land: AND WE do hereby also reserve unto Us, Our Heirs and Successors, all Petroleum (the term "Petroleum" to have the same meaning as in "The Petroleum Act, 1973 to 1976"), on or below the surface of the said Land: And also all rights of access for the purpose of searching for, and for the operations of obtaining Petroleum in any part of the said Land: And also all rights of way for access and for pipe lines and other purposes requisite for obtaining and extracting Petroleum in the event of Petroleum being obtained in any part of the said Land: Provided always, that if the Terms, Conditions, Reservations, and Provisions herein contained be not duly observed and performed by the said


